

- water (some emergent marsh in summer)
  - water (mud at winter low tide; mostly emergent marsh in summer)
  - ▨ extreme low tide line
  - ▨ mostly perennial open tidal marsh
  - ▨ shrub scrub marsh / forested swamp (mostly tidal)
  - ▨ indistinct marsh (mostly non-tidal)
  - ▨ streams; narrow tidal slough
  - ▨ seasonal watercourse; water hole
  - ▨ narrow marsh or trickle; spring
  - open land
  - ▨ rough open land
  - ▨ scattered trees
  - ▨ forest with little undergrowth
  - ▨ forest with thick undergrowth
  - ▨ forest with very thick undergrowth
  - very large or lone tree
  - ▨ distinct vegetation boundary
  - ▨ wall; rock pile
- ▨ sanctuary boundary
  - white UTM 100 meter grid pole
  - x small manmade feature
  - T tree stand
  - ruin; building
  - ▨ powerline with pole
  - ▨ fence; high fence
  - ▨ gates
  - ▨ narrow abandoned track
  - ▨ indistinct path (no footbridge)
  - ▨ small path (with footbridge)
  - ▨ boardwalk / pier
  - ▨ larger path or narrow vehicle track
  - ▨ dirt road; paved road
  - ▨ paved (parking) or surfaced (platform) area
  - ▨ gravel or dirt surfaced (parking) area
  - ▨ contours with a downhill slope tag
  - ▨ intermediate contour with a downhill slope tag
  - ▨ earth wall
  - ▨ small erosion gully; large erosion gully
  - ▨ earth cliff
  - ▨ broken ground; small knoll
  - ▨ small depression; small pit
